## Car park terms of use in Legendia – Silesian Amusement Park

1. Śląskie Wesołe Miasteczko Sp. z o.o. in Chorzow has three car parks which are at disposal to customers of the Legendia Silesian Amusement Park: a. main car park P1 located in the Złota street, which is part of the Legendia park, b. secondary car park P2 located in the Źródlana street in Katowice, c. secondary car park P3 located in the Dębowa street in Katowice.

2. The main car park is not guarded and there is a surcharge for parking. Secondary car parks P2 and P3 are not guarded and free of charge.

3. Secondary car parks P2 and P3 are available only when the main car park (P1) is fully occupied.

4. Once a car enters a car park, it is considered to be using the car park.

5. Once a car enters any of the above mentioned car parks, every car user declares that they agree to these terms of car park use and undertake to respect them.

6. There is a surcharge for parking at the main car park based on the effective price list that is available on information boards at the car park, online on: www.legendia.pl, at car park ticket offices and in the information centre.

7. Parking at secondary car parks (P2 and P3) is free of charge only for clients of the Legendia Silesian Amusement Park who want to park their cars while using the amusement park.

8. To leave the main car park, every car user must pay for their parking ticket that can be purchased at ticket offices, in the information centre or at parking meters.

9. Park visitors with valid season tickets can use their season tickets to leave the main car park. Visitors with valid season tickets can use the car park also when the facility is out of service, i.e. from the first day to the last day of the season. If any car is parked improperly and makes it hard for other cars to park or disrupts traffic, it can lose the right to park for free.

10. To leave secondary car parks (P2 and P3), car users have to use amusement park tickets valid on the day of parking.

11. Business partners and individuals who park their cars at any of the above mentioned car parks when having a business meeting in the Company can use the car parks for free but they must inform the information centre about it.

12. Parking fees are attached to the Terms of parking. Information boards with terms of car park use and parking fees are located at car park entrances and are clearly visible.

13. If any car user loses their parking ticket, there is a surcharge based on the current parking price list.

14. Leaving a car at any of the car parks is not equal to concluding a safekeeping contract in accordance with art. 835 Civil Code. When parking their car, every car owner is renting the parking space they choose.

Elements such as boom gates and barriers serve only for preventing car users from leaving the car park without paying their parking fees.

15. A boom gate which opens automatically serves as the car park entrance.

16. Any of the above mentioned car parks cannot be entered by vehicles transporting dangerous cargo, especially: flammable and explosive substances, corrosives and similar substances if they are not secured in accordance with applicable legislative. Regardless of security measures, every car owner, including drivers transporting dangerous cargo is liable for any damage caused to people or property when they enter a car park or park their vehicle there.

17. Car parks are traffic zones, i.e. regulations of the Road Traffic Act (Journal of Laws of 2012, item 1137 as subsequently amended) apply and the maximum speed is 20 km/h.

18. Every person using any of the above mentioned car parks is obliged to respect all horizontal and vertical traffic signs and follow the instructions of the amusement park staff.

19. Using the car park infrastructure includes passing the car park area or leaving the car in the area of the car park.

20. In the area of car parks, access and exit roads, it is forbidden to: a. repair, wash cars, change or refill oil, refrigerant, fuel and other liquids, b. park on access roads or park in the way of other vehicles entering car parks, c. drive around car parks for other reasons than parking or leaving the car parks, d. do business or offer commercial services of any kind without a prior written consent of the Company.

21. Every car park user is obliged to: a. keep all car parks clean, b. follow all fire safety and sanitary regulations, c. respect all instructions of the Company staff as well as the staff and security services responsible for car parks.

22. Parking fees can be paid at ticket offices in the amusement park, in the information centre or when leaving the car park based on a purchased parking ticket.

23. VAT invoices for parking services can be issued in the information centre if asked by clients. To do so, every client must show their parking ticket/receipt.

24. Every car park user is obliged to park their car so that it does not obstruct other park users.

25. Every car user is liable for any damage caused to the Company or to third parties in the area of the car park they are using and nearby in accordance with the Civil Code.

26. It is forbidden to leave pets that cannot enter the amusement park in cars or near them.

27. Every vehicle parked at a car park must be locked and everything inside must be properly secured. Valuable items cannot be visible.

28. The Śląskie Wesołe Miasteczko Sp. z o.o. company is not liable for lost or damaged powered vehicles located in the area of any car park, or items left inside.

29. Any suggestions and complaints related to car parking services shall be reported directly to the Company (by phone: 666-031-196 or by email: <u>info@legendia.pl</u>).
